TIPS FROM A LEGAL ASSISTANT A QUICK GUIDE TO HELPING YOUR WORK COMP CLAIM

• Update the office with ANY new information regarding your case (upcoming doctor's appointments, re-injuries, change of contact information, etc.)

 Please be specific whenever giving any information to the office (know dates, names of prescriptions, doctors, adjusters, etc.)

• Send copies of ALL documents you receive from the doctor's office to us.

 Ask for a copy of your office note and/or work status at your appointment. Often times, it is easier for you to get a copy than it is for us.

• When calling the office, please leave a detailed voicemail of the issue/question/concern that you have along with your name and call back number or send a text/email.

• Be patient; updates are not always going to be immediate.

WHAT IS ALABAMA DISABILITY DETERMINTATION SERVICES?

Disability Determination Services, commonly called "DDS," is the state agency funded by the US federal government. Its purpose is to make disability findings for the Social Security Administration. Applicants for Social Security Disability Insurance ("SSDI") or Supplemental Security Income ("SSI") file applications for benefits at local Social Security field offices. If the application is accepted, it is sent to the DDS in Alabama to have the claim of disability assessed. The claim is either approved or denied at the DDS for disability qualification. The claim is then returned to the originating SSA office to finish its processing. If you have questions or concerns about applying for Social Security benefits, please call Bernard or John. Page 3 Coronavirus is affecting every aspect of daily life including federal, state, and local governments. The

courts have had to adjust their rules in light of the pandemic. The Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") was extended in April to afford additional relief to Debtors in current bankruptcy cases. We have put together this FAQ to help our clients navigate the new bankruptcy rules. This is not legal advice but guidelines.

ARE THE BANKRUPTCY COURTS STILL OPEN?

Yes. However, most court hearings will be done over the phone and not in person. The Judges have indicated that in-person hearings will commence in the Northern District of Alabama beginning October 1, 2021. With the resurgence of cases, it remains to be seen whether this date will be extended.

HOW WILL MY MEETING OF CREDITORS BE CONDUCTED?

Until further notice, all pending meetings of creditors will take place by telephone as instructed on the Notice of your Bankruptcy Case. There is a phone number and access code listed on the Notice. Once you enter the conference call, place your phone on mute and wait for your case to be called. Do not place your call on hold or leave your phone unattended.

CAN I KEEP MY ECONOMIC RELIEF PAYMENTS?

Yes, the Trustee will not seek a turnover of any economic relief payments related to coronavirus. These payments are not considered property of the estate. Also, these payments will be excluded from your income for purposes of calculating your disposable income and the Means Test to determine if you qualify for Chapter 7.

WHAT IF I CAN'T MAKE MY CHAPTER 13 PLAN PAYMENTS DUE TO COVID-19?

You can request a suspension of your payments or file a Motion to Modify your Plan to extend the plan term up to an additional 24 months. Normally, Chapter 13 plans are limited to 60 months. However, the CARES Act allows plans to be modified up to an additional 24 months to assist people impacted by the Coronavirus.

WHAT IF I CAN'T MAKE MY MORTGAGE PAYMENTS DUE TO COVID-19?

Although many mortgage lenders are offering grace periods, the bankruptcy court still expects you to make your mortgage payment. If you are unable to pay you should contact your mortgage company to inquire about a loan modification to bring your mortgage account current.



INJURED WORKING AT HOME? DOES WORK COMP COVER THAT?

COVID-19 has changed our world. One of those changes includes millions of more people working from home, also known as working remotely or telecommuting. With millions of more employees working from home, telecommuting and work comp claims will only increase. If you get hurt working from home, can you receive workers' compensation benefits? Yes, you can.

Most work accidents occur in or near the traditional brick and mortar location of the business, like a factory, warehouse or construction site. If you get hurt while working from home, the location of the accident is not a key factor in determining whether you will receive work comp benefits but rather that the injury arises out of and occurs in the course of employment. If the employee is injured while performing a work task during work hours, then the injury is compensable under workers' compensation insurance.

While more employees are working remotely than ever before, proving an on the job accident will still require the injured worker to prove that the accident occurred in the course of and arose out of the employment.
